General Promotion Terms and Conditions

- The promotion Flamingo CASH VIBES 2022 (the "Promotion") is offered by JVH gaming & entertainment B.V. and Interamusement Beheer B.V., both having offices at Europalaan 26, 5232 BC in Den Bosch (hereinafter: "JVH").
- 2. These General Promotion Terms and Conditions apply to the Promotion.
- The Promotion is intended to promote the branches that trade under the name Flamingo Casino and concerns a promotional game of chance pursuant to the Code of Conduct for Promotional Games of Chance.

Duration

1. This Promotion runs from 19 May 2022 through 2 June 2022 (the "Promotion Period").

Participation

- Participation in the Promotion is free of charge and possible only during the Promotion Period.
- During the Promotion Period, guests of a Flamingo Casino will receive one (1) participation ticket upon admission. Guests who are Luckey members will receive two (2) tickets upon admission. A Luckey member is a guest with a Luckey pass + activated account.
- Each guest is entitled to a maximum of 1 ticket per day during the Promotion Period.
 - Each Luckey member is entitled to a maximum of 2 tickets per day during the Promotion Period.
- 5. Only guests who have legitimately received a ticket may participate in the Promotion.
- 6. These participation tickets can be obtained until 2 June 2022 6:00 p.m.
- 7. On 2 June 2022, the guest can put the received tickets in the lottery bowl between 6:00 p.m. and 8:00 p.m. Earlier or later submission of the participation ticket is not permitted.
- 8. On 2 June 2022, starting at 8 p.m., multiple winners will be drawn for each Flamingo Casino branch.
- 9. The guest puts the drop-in slip in the lottery bowl. The guest keeps the tear-off slip for verification.
- 10. Each CASH prize will be raffled off via a separate draw.
- 11. The winner of the draw may select 1 of the gold envelopes not yet chosen.
 - Inside the envelope is a check stating the CASH amount of the participation ticket.
- 12. The amount won will be paid out to the winner immediately.
- 13. Guests must be present for the draw.
- 14. If the winning guest does not report within 2 minutes of the winning ticket being drawn, this ticket number will be cancelled, and he or she will no longer be entitled to the prize. A new ticket will be drawn.
- 15. Persons under the age of 18 or 21, depending on the admission age of a Flamingo Casino branch, persons with an entry ban, employees and family members of JVH and all its affiliates and persons directly or indirectly involved in the organisation of the Promotion are excluded from participation.
- Persons who violate the General Promotion Terms and Conditions will be excluded from participation and/or entitlement to a prize.

Privacy

 Private data obtained by JVH in connection with participating in the Promotion will be entered into its database, if and to the

- extent permitted by law. This data will be used to inform the participant of further information, promotions and offers of JVH, all in accordance with the GDPR (General Data Protection Regulation) and any related regulations based on the GDPR.

Complaints procedure

- 3. You will receive a confirmation in writing of your complaint within 2 weeks. Once all data are complete, we will handle the complaint and will keep you informed in writing of the settlement of the complaint. If your data are incomplete and/or lacking, we will always attempt to contact you. We strive to settle the complaint within 4 weeks after confirmation. Your complaint will be handled by our Quality & Assurance department and/or Legal Affairs department. If you are of the opinion that the complaint was not handled correctly, you will have the right to apply to the Netherlands Gaming Authority (www.kansspelautoriteit.nl).

In conclusion

- 4. JVH is not liable for any typing errors, printer's or typesetting errors and/or any damage as a result of changing or terminating the Promotion or any damage arising from a technical breakdown or defect.
- 5. At any time, JVH has the right to change the Promotion Terms and Conditions, or to discontinue the Promotion, such without giving reasons or prior notice. In the event the Promotion is changed or terminated, this will be communicated at www. flamingocasino.nl.
- In cases not covered by the Promotion Terms and Conditions, a decision will be made by JVH's operational management.
- 7. Where relevant, JVH will pay the tax on games of chance in respect of the prizes that are won.
